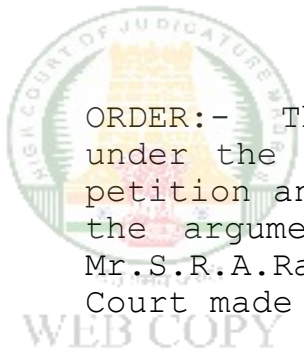

Contempt Petition filed under Section 11 of Contempt of Courts Act, to punish the contemnors / respondents herein for committing grave contempt and gross disobedience of the order passed by this Court in WP(MD).No.6388 of 2022 dated 11-04-2022.

Prayer in WP(MD). 6388/ 2022 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondent 1 and 2 to grant permission to the petitioner to enter into lease agreement for agriculture activities in their punja land in survey No. 1052/2, with the extent of 50 acre, situated at Pathai Pagam II, Nanguneri Taluk, Thirunelveli District, based on their application dated 25.02.2022.
