Decree:-

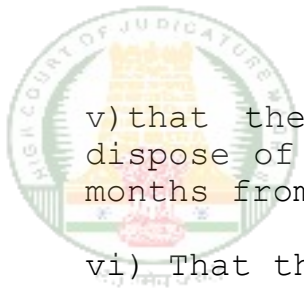

ii)that, interim maintenance amount fixed to the revision petitioner be and is hereby reduced to Rs.8000/-(Rupees Eight Thousand Only) per month from the date of petition i.e 22.02.2016;

iii)that, the revision petitioner husband be and is hereby directed to pay arrears of maintenance in three installments and in first installment shall to pay a sum of Rs.2,00,000/-(Rupees Two Lakhs only) on or before 18.04.2022;

v)that the Sub Judge, Kovilpatti, be and is hereby directed to dispose of the case in HMOP NO.107 OF 2015 with in a period of two months from the date of receipt of a copy of this order; and
