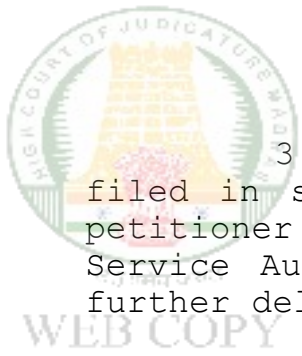
PRAYER IN CRP(MD)SR No.49493 of 2020 :

ORDER : This petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.J.JEYAKUMARAN, Advocate for the petitioner and of MR.P.R.PRITHVIRAJ, Advocate on behalf of the Respondent, the court made the following order:-

This Civil Miscellaneous Petition is filed to extend the time in the order made in CMP No.371 of 2021, in CRP(MD) SR No.49493 of 2020, by this Court, dated 09.02.2021.

2.This Court by earlier order dated 09.02.2021, allowed the petition filed by the petitioner for condonation of delay of 87 days in filing the Civil Revision Petition with a condition to pay a sum of Rs.500/- to the Legal Aid Service Authority.
