3.The learned Government Advocate (Crl.side) submitted that the petitioner has been complying with the conditions regularly.

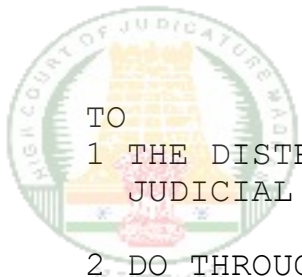
