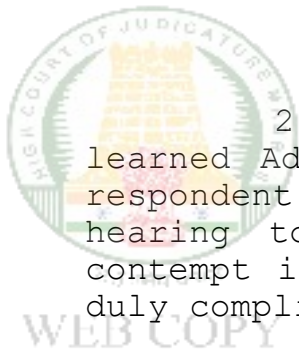
Prayer in CRL OP(MD).No. 13470 of 2020
