When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the respondents submitted that on receiving the complaint from the Judicial Magistrate No.II, Dindigul in Cr.M.P.No.45 of 2022, dated 27.01.2022, the case has been investigated by the respondent police and the investigation found that no document has been registered before the Sub Register office. Further, the third accused viz., Doctor stated that he should not identify the parties before giving the life certificate as they wear Corona Mask.
