2.Today, when the matter was taken up for hearing, the learned Government Advocate (Crl.side) appearing for the respondent police would submit that there are two rival groups for conducting the temple festival, by name Sri Mahakaalamman Temple situated at Kothamangalam, Subramaniyar Temple street, Trichy. Therefore, the second respondent requested the Revenue Divisional Officer to conduct peace committee meeting and the said Revenue Divisional Officer has also fixed peace committee meeting to be held on 24.09.2022.
