This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus to direct the respondents herein to grant permission and protection to conduct the 'Aadal Padal' programme on 06.08.2022 at around 7.00 p.m. to 11.00 p.m. at Thiruppathur Bus Stand, Sivagangai District based on the petitioner's representation, dated 27.07.2022.

2.Mr.M.Sakthikumar, learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3.The learned counsel appearing for the petitioner submitted that temple festival, by name, Arulmigu Rajakaliyamman Temple is going to be held on 06.08.2022. Subsequent to the same, in order to conduct a cultural programme, they sought permission of the police by giving a representation dated 27.07.2022. But the respondent police has not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc.007301/Genl.I (1)/2019 dated 09.04.2019 along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the third respondent is hereby directed to consider the representation of the petitioner dated 27.07.2022 and pass suitable orders based on the above said circular.
