This Criminal Original Petition has been filed for a direction to direct the I Additional District and Sessions Judge cum Special Judge, P.C.R court, Trichy to consider the bail application of the petitioners on the same day of their surrender before that court in connection with Crime No. 115 of 2022 on the file of the respondent.

2. In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to the I Additional District and Sessions Judge cum Special Judge, P.C.R court, Trichy, to consider the petitioners bail application, preferably on the same day of their surrender in connection with Crime No. 115 of 2022 on the file of the second respondent and pass appropriate orders, in accordance with law, after affording due opportunity to the victim under Section 15(a) of the SC/ST Act. The petitioners shall surrender before the concerned jurisdictional Court, within a period of fifteen days, from the date of the receipt of a copy of this Order.
