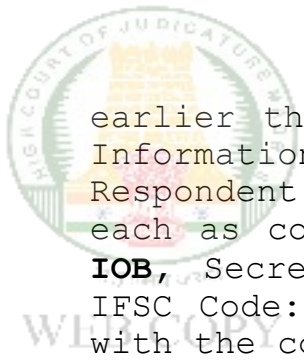
Prayer in CRL.OP.(MD)No.5138 OF 2022:-

Since the Petitioner was unable to comply with the condition he has filed this petition.
