3.The learned Government Advocate (Crl.Side) submitted that the petitioner has been complying the condition regularly and investigation is still pending.

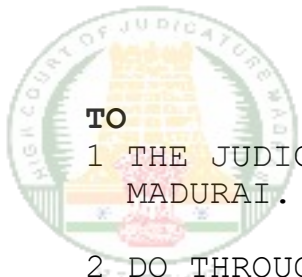
