4. Heard the learned counsel appearing for the petitioners and the learned Government Advocate (crl. side) appearing for the respondent police.

5. The facts of this case is similar to the facts covered by the Judgment of this Court reported in ***2018 2 LW (Crl) 606 [Jeevanandham and others Vs. The Inspector of Police Velayuthampalayam Police Station, Karur District] Dated 20.09.2018*** and in the case of ***Sri Raja Vs. Inspector of Police, Sivakasi Town Police Station, Virudhunagar District and other*** in batch of cases in ***Crl.O.P.(MD)No.7922 of 2019 dated 30.08.2019***. Accordingly, the proceedings in Crime No. 107 of 2020 on the file of the respondent police, is quashed insofar as the petitioners alone and
