ORDER

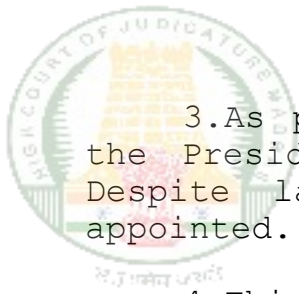
Heard the learned counsel for the petitioner and the learned Special Government Pleader for the respondents.
