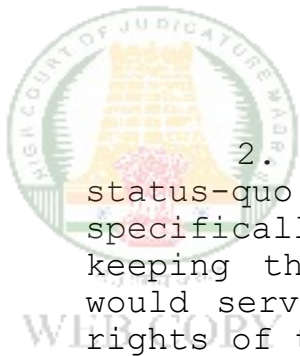

Under these circumstances, keeping the Contempt Petitions may not be required, as the same would serve no purpose for the cause of justice. Contrarily, the rights of the parties to be crystallized based on the writ petitions filed. Accordingly, the contempt petitions are closed.
