This writ petitioner filed this Writ Petition seeking direction to the 1st respondent to take action on the petitioner's representation, dated 26.07.2022 and to grant police protection to the petitioner's life and limb and her properties in Survey Nos.782, 783, 784, 785/1, 785/2 which are situated in Tirunelveli Town, Tirunelveli District as per Rule 21 of Tamil Nadu Maintenance and Welfare of Parents and Senior Citizens Rules, 2009.

2.Today, when the matter is taken up for hearing the learned Government Advocate (criminal side) appearing for the respondent Nos.1 & 2 submitted that earlier private respondent has preferred a complaint against the petitioner and also this Court has issued direction by its order, dated 20.07.2022 in CrI.O.P.(MD)No.12728 of 2022 to consider the complaint. The private respondent has not appeared for enquiry. and now, the complaint is pending. The submission is recorded.

4.With the above observation, this Writ Petition is disposed of.
