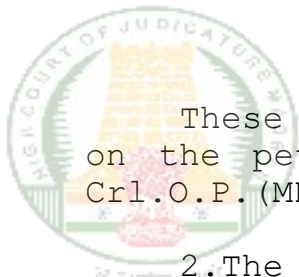
PRAYER IN CRL MP(MD)No.9449 of 2022:
