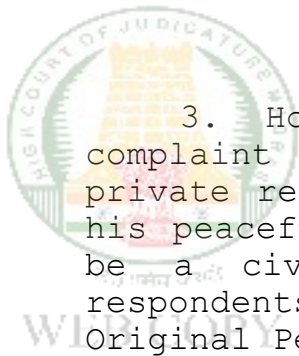

4. Accordingly, this Criminal Original Petition is dismissed. However, the petitioner is at liberty to lodge a fresh complaint on the fresh cause of action.
