This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus, directing the respondent to grant permission and protection for cultural event namely Adal Padal scheduled to be held on 18.08.2022 at 09.00 p.m to 12.00 a.m in connection with 8th day of “Kodai Vizha” in Arulmigu Devi Sri Mutharamman Temple at Vijayaramapuram, Thatchamozhi Village, Sathankulam Taluk, Thoothukdu District, by considering the petitioner's representation dated 02.08.2022.

2.Mr.M.Sakthi Kumar, learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3.The learned counsel appearing for the petitioner submitted that the petitioner seeks permission for conducting the cultural programme viz., “Adal Padal” scheduled to be held on 18.08.2022 at 09.00 p.m to 12.00 a.m in connection with 8th day of “Kodai Vizha” in Arulmigu Devi Sri Mutharamman Temple at Vijayaramapuram, Thatchamozhi Village, Sathankulam Taluk, Thoothukdu District . Subsequent to the same, in order to conduct a cultural programme, they sought permission of the police by giving a representation dated 02.08.2022. But the respondents have not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

4.The learned Government Advocate (criminal side) appearing for the respondents police would submit that the respondents have received the representation of the petitioner and the same is pending for consideration.
