Side) on behalf of the Respondent, the court made the following order:-

This petition has been filed to relax the condition imposed on the petitioner in CRL.O.P.(MD)No.12151 of 2022, dated 06.07.2022.

2. When the matter was taken up for hearing on 17.08.2022, the learned counsel appearing for the petitioner submitted that even though the petitioner appeared before the respondent police, they did not permit him for signing in the records for compliance.



Therefore, this court directed the Station Officer to appear before this Court today.

3. The Station Officer present before this Court and submitted that even after issuing notice under Section 41(A), the petitioner is not co-operating for enquiry.

4. Since the wrong representation has been made by the petitioner as if the respondents are not permitting, this petition deserves to be dismissed.

5. Accordingly, this petition is dismissed.
