ORDER

2.The petitioner challenges the peace committee meeting minutes drawn on 12.04.2022. It has been held time and again that such decisions are not amenable to legal challenge. They are bereft of any statutory value or force. In any event, the Tahsildar, Kariyapatti Taluk cannot decide who will be the poojari of the petition mentioned temple. These are matters that will have to be decided elsewhere. A decision taken in peace committee meeting can never be enforced by the statutory authorities.
