ORDER

[Order of the Court was made by R.MAHADEVAN, J.]

The prayer in this writ petition is for issuance of a writ of mandamus directing the respondents 1 to 7 to remove the encroachment made by the respondents 8 to 12 in S.F.No.68/1 of Vaithikulam Village, Vaithur Post, Kulathur Taluk, Pudukkottai District, which is classified as “Government Poramboke (Grassing Ground)” in the revenue records and to restore the same to its original position, based on the petitioner's representation dated 30.08.2021.

2. When the matter was taken up for hearing, the learned Government Pleader appearing for the respondents 1 to 7, on instructions, submitted that there are some encroachments, as projected by the petitioner, in the subject land and the same would be removed, in accordance with law, within a period of eight weeks.

3. Recording the above submission of the learned Government Pleader, the authority concerned is directed to remove the encroachments made by the private respondents in the subject land after giving due notice to
