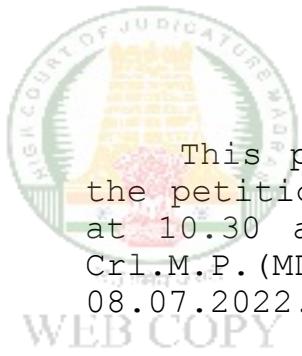
Prayer in CRL MP(MD) . 6223/ 2022 :
