The prayer in this writ petition is for issuance of a writ of mandamus directing the respondents 1 to 6 to provide pathway to the petitioner for reaching his dwelling house situated in Door No.2/52A, Kakkayakkon Street, Pattathikadu Panjayat, Thirumananjeri Post, Karambakudi Taluk, Pudukottai District and to remove the illegal encroachment made by the seventh respondent in the common pathway in Survey No.87/39 of Pattathikkadu Village, Karambakudi Taluk, Pudukottai District, based on his representation dated 17.09.2021 in accordance with law, within a time frame.

2. Today, when the matter was taken up for hearing, the learned Government Advocate appearing for the respondents 1 to 6 a, on instructions, submitted that the subject land is nothing but a patta land and there is no encroachment, as projected by the petitioner.
