### **ORDER**

2.The petitioner is a dairy farmer. His grievance is that the respondent society is declining to purchase milk from him. It appears that there was some misunderstanding between the petitioner and the management of the respondent society. The petitioner has given an undertaking that he will not interfere in the internal affairs of the respondent society. Recording the said undertaking, the fifth respondent has now informed the Court that they will issue monthly milk coupon to the petitioner herein.

3.In view of the said submission, the fifth respondent is directed to issue monthly milk coupon to the writ petitioner and also purchase milk from him.
