identified by Mr.R.Gomathinayaranan, SSI of Police, V.K.Puram Police Station as well as by the learned Counsels appearing for the parties. This Court also enquired both the parties and was satisfied that the parties have come to an amicable settlement between themselves.

5. In the instant case, the dispute is of personal in nature and the parties had compromised. Where the parties have compromised the matter, the High Court has to power to quash the complaint for the offence under Sections 294(b), 352 and 506(1) IPC.

6. The legal position expressed by the Hon'ble Apex Court in the case of **Gian Singh vs. State of Panjab and another** reported in **(2012)10 SCC 303** and **Parbathbhai Aahir @ Parbathbhai Vs. State of Gujrath** reported in **(2017)9 SCC 641** were taken into consideration.

7. In the light of the guidelines issued in the above said Judgments of the Hon'ble Apex Court, no useful purpose will be served in keeping the proceedings in STC No. 288 of 2022, on the file of the learned

Judicial Magistrate, Ambasamuthiram, Tirunelveli even though, the offences involved are not compoundable in nature.

8. Accordingly, this Criminal Original Petition stands allowed and as a sequel, the proceedings in STC No. 288 of 2022, on the file of the learned Judicial Magistrate, Ambasamuthiram, Tirunelveli is quashed and the terms of joint compromise memo shall form part and parcel of this order.
