3.Mr.R.Meenakshi Sundaram, the learned Additional Public Prosecutor appearing for the respondents 1 and 3 submitted that on the basis of the complaint given by petitioner, enquiry has been undertaken by the second respondent and depending upon the out come of the enquiry, the further action has been taken against the concerned person.
