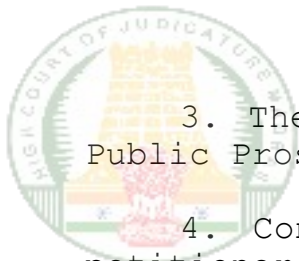
PRAYER IN CRL A(MD)No. 440 OF 2022:
