### **ORDER**

This writ petitioner filed this Writ Petition seeking a direction to the 3<sup>rd</sup> respondent police to restrict his jurisdiction, only to obtain the signature from the petitioner, every day by 10 A.M. on his appearance in the police station and relieve him to go away from the police station, without detaining him or harassing him from in any manner.

2.Mr.M.Sakthi Kumar, learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3.The learned counsel appearing for the petitioner submitted that the petitioner has appeared before the 3<sup>rd</sup> respondent police daily, in lieu of the conditional order passed by the learned Judicial Magistrate No.II, Pudukkottai, in Crl.M.P.No.1080 of 2022 by its order, dated 28.02.2022. While the petitioner appearing before the 3<sup>rd</sup> respondent police for signing, the 3<sup>rd</sup> respondent police harassed him. Hence this petition.

4.When the matter is taken up for hearing, the learned Government

Advocate (Crl. Side) submitted that the petitioner, in pursuance of the order passed by the learned Judicial Magistrate No.II, Pudukkottai in Crl.M.P.No.1080 of 2022, dated 28.02.2022, he is appearing before the 3<sup>rd</sup> respondent police, daily. The statement is recorded.

4. Recording the same, the 3<sup>rd</sup> respondent police is directed to not to harass the petitioner while he is appearing before him for signing, in pursuance of the order passed by the learned Judicial Magistrate No.II, Pudukkottai, in Crl.M.P. No.1080 of 2022 dated 28.02.2022.

5. With the above direction, this Writ Petition stands disposed of.
