ORDER : This petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.S.ARUNACHALAM, Advocate for the petitioner and of MR.K.JAGADEES BALAN, Advocate for the respondent, the court made the following order:-

When the matter is taken up for hearing today, the learned counsel for the petitioner submits that the contempt petition (MD) No.142/2021 was closed on 08/03/2021 for the reason that a writ appeal(MD)No.515/2020 was pending. However, the writ appeal was dismissed on 08/03/2021 and as against the said judgment, a special



Leave petition was also filed. The same was also dismissed. He further submits that the award of the Labour court has not been complied with.

In Light of the submissions and subsequent developments after closure of the contempt petition, this sub-application is allowed and the contempt petition (MD)No.142/2021 is re-opened.

For further hearing, Post the contempt petition after eight weeks.
