Prayer :- Civil Revision Petition filed under Article 227 of Constitution of India, to direct the Learned Additional District and Session Court, Virudhunagar to dispose the E.P.No.17/2020 in A.F.No.139/2018 (O.P.No.250/2018 on the file of the Sole Arbitrator) pending on the file of the Learned Additional District and Session Court, Virudhunagar in a speedy manner within a time frame as fixed by this Hon'ble Court and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.

ORDER:- This Civil Revision Petition coming on for orders on this day and upon perusing the earlier order of this Court dt.10.01.2022 and the requisition letter submitted by the Additional District Judge, Virudhunagar, in D.No.697 dated 14.03.2022 and this Court made the following order:-

As per the order passed by this Court dated 10.01.2021, the learned Additional District & Sessions Judge, Virudhunagar was directed to dispose of E.P.No.17 of 2020 in A.F.No.139 of 2018, within a period one month, from the date of receipt of a copy of the order. The learned Additional District & Sessions Judge, Virudhunagar requested for extension of time limit. The case was posted on 14.02.2022 and adjourned to 23.03.2022. Since a direction was issued to dispose of the matter within one month, the learned Judge should not adjourn the matter beyond a period of one month.



2.However, one month time is finally granted to dispose of the matter. The learned Additional District & Sessions Judge, Virudhunagar is severely warned to dispose of the matter within time frame.
