ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a ***Writ of Mandamus*** directing the respondents to grant permission and necessary protection to conduct the Adal Padal Programme on 04.09.2022 at 6.00 PM to 11.00 PM in connection with Thiru Vizha of Arulmigu Sri Sakthi Vinayagar Thirukovil at Kulathur, Kulathur Taluk, Pudukkottai District.

2.Mr.M.Sakthikumar, learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3.The learned counsel appearing for the petitioner submitted that 'Aadal Padal' programme at Kulathur, Kulathur Taluk, Pudukkottai District, on 04.09.2022. Subsequent to the same, in order to conduct Aadal Padal, they sought permission of the police by giving a representation dated 18.08.2022. But the second respondent has not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc.007301/Genl.I (1)/2019 dated 09.04.2019 along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting tournament. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent police is hereby directed to consider the representation of the petitioner dated 18.08.2022 and pass suitable orders based on the above said circular.
