This writ petitioner filed this Writ Petition seeking for issuance of a ***Writ of Mandamus*** directing the respondents to grant permission and protection to conduct Aadal Padal Programme on 29.08.2022 and 30.08.2022 from 08.00 pm to 11.00 pm in pursuant to the Vinayagar Chathurthi Festival of Arulmigu Sakthi Vinayagar Temple situated at Pudukudi Village, Kottaipattinam Post, Manamelkudi Taluk, Pudukkottai District by considering petitioner's representation dated 22.08.2022.

2.Mr.M.Sakthikumar, learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3.The learned counsel appearing for the petitioner submitted that 'Adal Padal' in connection with the Vinayagar Chathurthi Festival of Arulmigu Sakthi Vinayagar Temple situated at Pudukudi Village, Kottaipattinam Post, Manamelkudi Taluk, Pudukkottai on 29.08.2022 and 30.08.2022. Subsequent to the same, in order to conduct a Aadal Padal, they sought permission of the police by giving a representation

dated 29.08.2022. But the second respondent has not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

4.The learned Government Advocate (criminal side) appearing for the respondent police would submit that the second respondent has received the representation of the petitioner and the same is pending for consideration.

5. I have considered the submission of the learned counsel appearing for the petitioner and the learned Government Advocate (criminal side) appearing for the respondent police.

6. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc.007301/Genl.I (1)/2019 dated 09.04.2019 along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting tournament. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent police is hereby directed to

consider the representation of the petitioner dated 29.08.2022 and pass suitable orders based on the above said circular.

7. With the above direction, this writ petition is disposed of.
