2. When the matter is taken up for hearing, the learned Additional Public Prosecutor would submit that investigation has been completed and final report has also been filed before the concerned Court on 05.03.2020 and the same has not been taken on file so far.

3.The learned counsel for the petitioners would submit that since final report was filed before the concerned Court, a direction may be issued to the learned Additional Mahila Court, Madurai, to dispose of the matter within a short time prescribed by this Court.
