The third respondent is also directed to consider the petitioner's representation, dated 29.07.2022 subject to the result of the enquiry to be conducted by the Revenue Divisional Officer on the request of the respondent police under Section 145 of Cr.P.C. and take suitable action on merits, by considering all the documents to be produced by the petitioner.

4.With the above direction, this Writ Petition is disposed of.
