Today, when the matter is taken up for hearing, the learned Government Advocate (crl. side) appearing for the respondents submitted that, at the time of alleged murder, the petitioner was residing in his house which was located in opposite to the deceased house. He further submitted that the occurrence was happened in the year 2009 and the police officials are not harassing
