**Prayer in CRL RC(MD) . 752/ 2021 :**

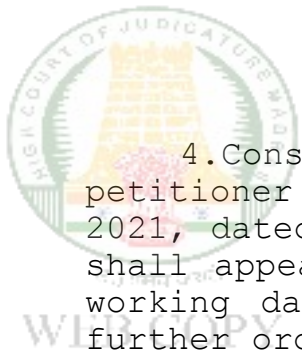
