Today, when the matter is taken up for hearing, the learned Government Advocate (crl. side) appearing for the respondents submitted that the petitioner gave a complaint against his brother's family and there is a dispute between them. He further submitted that, with regard to the family properties, both the parties have given complaint. Since dispute between the parties pertaining to the family properties the 3rd respondent/Inspector of Police has referred the matter to the RDO,
