The writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus directing the respondents to grant permission to the 'Aadal Padal' program to be held on 31.08.2022 at about 06.00 p.m. in Arulmighu Sri Vinayagar Temple at Silambampatti, Amma Chathiram Village, Marungapuri Taluk, Trichy District based on the petitioner's representation dated 25.08.2022.

2.Mr.M.Sakthikumar, learned Government Advocate (Criminal Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3.The learned counsel appearing for the petitioner submitted that temple festival, by name, Arulmighu Sri Vinayagar Temple situated at Silambampatti, Amma Chathiram Village, Marungapuri Taluk, Trichy District, is going to be held on 31.08.2022. Subsequent to the same, in order to conduct a cultural programme, they sought permission of the police by giving a representation dated 25.08.2022. But the respondent police has not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent is hereby directed to consider the representation of the petitioner dated 25.08.2022 and pass suitable orders based on the above said circular.
