2.When the matter is taken up for hearing today, the learned Government Advocate (Crl. side) appearing for the respondents 1 to 3 would submit that after receiving the complaint, C.S.R. came to be registered in C.S.R.No.243 of 2022 on 13.05.2022 and the petitioner as well as the private respondents 4 to 6 were summoned and on enquiry, they came to know that that fourth respondent is running a finance institution and that they have received the complaints from some other persons and the respondents 4 to 6 and that they are taking steps to transfer all the complaints to Economic Offence Wing.
