Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records of the first respondent impugned order dated 28.02.2018 in R.C.No.68049/2017/D2 served with demand notice dated 09.03.2018 by the second respondent, quash the same and consequently directing the respondents to refix the revised rent as per guidance of market value in accordance with law according to that first respondent, to number the main appeal in R.C.No.68049/2017/D2 for initiating the trial proceedings.
