3. The third respondent filed Crl.O.P.(MD) No.16467 of 2019 seeking anticipatory bail. Vide order dated 13.11.2019 anticipatory bail was granted, since the third respondent undertook to deposit a



sum of Rs.3,00,000/- to the credit of Crime No.10 of 2019. Till date the third respondent has not complied with the said condition. Therefore, the order dated 13.11.2019 made in Crl.O.P.(MD)No.16467 of 2019 is set aside.

4. This petition is allowed on these terms.
