Prayer in CRL A(MD).430 of 2022 :

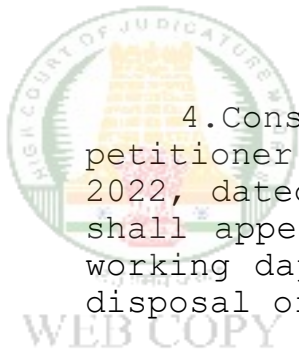
