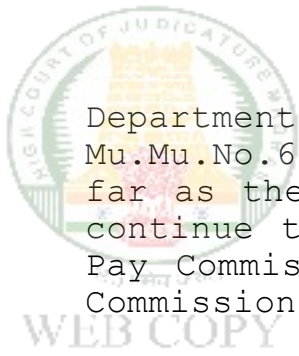

Department, dated 5.8.2005 and that of the 2nd respondent in Mu.Mu.No.61241/D2/E1/09 dated 4.12.2009 and quash the same, in so far as the petitioner is concerned, and direct the respondents to continue the petitioner's scale of pay of Rs. 1400/- as per V th Pay Commission and further revised at Rs.5000/- as per VI th Pay Commission and confer all the consequential benefits.
