Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, to direct the respondents more particularly the respondents 1, 3, 5, 7 not to permit anybody to increase the height, length and width of the Arasakulam Kanmoi situated in Survey No.202 Arasakulam Village, Senthattiyenthal Revenue Village, Manamadurai Taluk, Sivagangai District and thereby blocking / preventing the free flow of the water of the source channel of Mannar Mudiyyenthal Kanmoi situated in Survey No.43 of Mannar Mudiyyenthal Village, Erunchirai Revenue Village, Thiruchuli Taluk, Virudhunagar District and maintain the Arasakulam Kanmoi as per the measurement of the Government / Revenue Records based on the petitioner's representation dated 24.12.2021 submitted to the respondents 1 & 2 respectively as well as resolution passed in the peace committee meeting dated 15.12.2021 conducted by the Revenue Officers, within the time limit that maybe stipulated by this Court.
