2. The learned Counsel appearing for the Petitioner would submit that the Petitioner is running a furniture production unit in Kalingampatti Village, Athoor Taluk, Dindigul District. The said property belongs to the fourth Respondent. In the said property the Petitioner was inducted as tenant in the year 2009 and till date the Petitioner is paying the rent without any default. In these circumstances the fourth Respondent is compelling the Petitioner to vacate the property and hand over the possession. The Petitioner has also filed a suit against the fourth Respondent, while so the fourth Respondent filed a complaint before the third Respondent and the third Respondent is harassing the Petitioner under the guise of enquiry,
