2.The petitioner was convicted under Section 323 IPC by the trial Court, against which he filed the aforesaid appeal before the appellate Court, in which the sentence has been suspended. So, he can workout his remedy only after the disposal of the aforesaid appeal. So, according to him, this is the urgency.

Since the offence is simple in nature, there shall be a direction to the appellate Court to dispose of CA.No.93 of 2022 within a period of 3 months from the date of receipt of a copy of this order.
