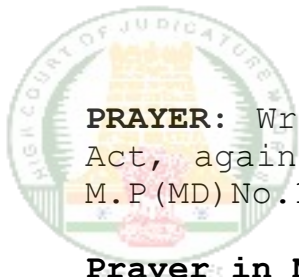

2. In view of the above, this writ appeal stands dismissed as withdrawn. No Costs. Consequently, connected miscellaneous petition is closed.

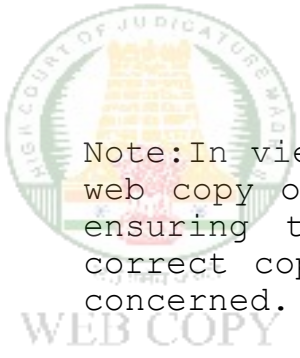
