(1) That the quantum of compensation be and hereby is reduced to Rs. 10,89,840/- (Rupees Ten Lakhs Eighty Nine Thousand and Eight Hundred and Forty only)

(2) That the direction given by the Tribunal for investment of the award amount be and hereby is set aside;

(3) That the apportionment made by the Tribunal of the award amount be and hereby is confirmed;

(4) That the Tribunal be and hereby is directed to pay over the balance award amount as per the modified award amount to the Claimants and any excess shall be refunded to the appellant herein/ Insurance Company;

(5) That there be no costs in this Civil Miscellaneous Appeal.
