ORDER

The present Writ Petition has been filed seeking a writ of Mandamus directing the official respondents to initiate action as against the fourth respondent College, by considering the representation of the writ petitioner dated 24.08.2013.

2. According to the learned counsel for the petitioner, the petitioner's daughter had studied B.Sc. (Physics) and applied for M.Sc. (Physics) before the fourth respondent College. She has secured higher marks, but she was
