Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records of the respondents particularly that of the impugned communication in ஓ.மு.எண்.14/18/ஆ1 dated 19.03.2018 addressed to the 2nd respondent by the 1st respondent and the consequential impugned order in Na.Ka.No.31/2018 dated 28.03.2018 and quash the same as illegal, unlawful, without jurisdiction and against the principles of natural justice and consequently direct the 2nd respondent to register the document presented by the petitioner in respect of the land in Town Survey No.8/4, Old Survey No.150/3 an extent of 0.40.40 Ars situated at Kodaikanal Town, Ward B, Black 10.
